BETWEEN OUR TWO HOUSES, WE'RE ABLE TO SERVE UP TO 118 FAMILIES EACH NIGHT. IN 2019, WE SERVED 2,028 FAMILIES FOR A TOTAL OF 32,190 NIGHT STAYS. FAMILIES ARE OFFERED SERVICES THAT MAKE THEM FEEL AT HOME AND WELCOME: DINNERS, PLAYGROUNDS, MESSAGES, OPPORTUNITIES TO ATTEND SPORTING EVENTS, GROUPS THAT COME TO THE HOUSES TO ENTERTAIN, PARTIES, AND MUCH MORE.
