BETWEEN OUR TWO HOUSES, WE'RE ABLE TO SERVE UP TO 118 FAMILIES EACH NIGHT. IN 2020, WE SERVED 1,204 FAMILIES FOR A TOTAL OF 18,975 NIGHT STAYS. FAMILIES ARE OFFERED SERVICES THAT MAKE THEM FEEL AT HOME AND WELCOME: DINNERS, PLAYGROUNDS, MASSAGES, OPPORTUNITIES TO ATTEND SPORTING EVENTS, GROUPS THAT COME TO THE HOUSES TO ENTERTAIN, PARTIES, AND MUCH MORE.
