BETWEEN OUR TWO HOUSES WE'RE ABLE TO SERVE UP TO 118 FAMILIES EACH NIGHT. IN 2022, 2,130 GUEST FAMILIES CHECKED INTO OUR HOUSES AND STAYED A TOTAL OF 33,200 NIGHTS COLLECTIVELY.
